EQUIPMENT FAQ & CONDITIONS

License to tow trailer – ordinary “C – class license”

Vehicle/Towing – the staging and trailer can towed by normal/regular road vehicle with (if applicable)

Pick-up – hirer is to arrange for the pick-up and return of all equipment

Conditions of Hire:

- ❖ All assembly etc. of equipment is to be undertaken by hirer unless by prior arrangement, charges may apply.
- ❖ All hirers to pay bond prior to picking up equipment, refundable upon satisfactory equipment return and inspection.
- ❖ Any equipment repairs and replacement of lost parts of will be paid by the hirer through the bond charges. If damage exceeds the bond payment the extra costs are to be met by the hirer.
- ❖ If the staging, trailer & equipment are not returned cleaned, extra charges & surcharges apply.
- ❖ Hire agreement forms to be completed prior to taking equipment and the hirer must advise us of any deficiencies prior to taking the equipment. If this does not occur, these deficiencies will be attributed to the hirer.
